In addition, they also offered parenting workshops in the •Parent conferences were held twice during the school year, with added conferences as needed. In addition, all parents were able to access the Parent Portal to review their child's progress throughout the year at any given time. Report cards were given four times throughout the year. •All teachers posted homework •All teachers participated in a curriculum night for parents to inform them of assignments on their web pages. the course content, expectations for behavior, expectations for homework completion, and grading practices. Email addresses, web page information, homework hotline information, and phone contact information were shared in order to facilitate the ease of communication. •Every student was given a planner at the beginning of the school year to record homework, as well as to provide a vehicle for home school communication. •There were monthly Principal's Coffees to provide opportunities for parents to gain information about the school and programs, as well as share concerns.

Bristow Middle School continued its efforts to provide many opportunities for students to interact with students and teachers from diverse racial, ethnic, and economic backgrounds throughout the 2012-2013 school year. •Bristow Middle School is a school of choice, drawing its own diverse student body from across the West Hartford School District. •Bristow has students enrolled who are from Hartford and participate in the Open Choice program. •Our after school intramural program, as well as clubs and activities continues to draw a diverse group of students who interact in a non-academic setting. •Students participated in a program presented by Calvin Terrell, the founder and lead facilitator of Social Centric; an organization he designed to provide education and training for all ages to enhance human interactions and global progress. Also, students had the opportunity to attend the Looking-In-Theatre and a performance by Dancers of the Americas where they were immersed in the cultures of Central and South America. •All of our students and families were given the opportunity to participate in family nights sponsored by the faculty such as Family Folk Dancing, Family Art Nights, Family Wellness Nights, and parenting workshops. •The PTO sponsored a community outreach project during the holiday season to support families in need.

SCHOOL IMPROVEMENT PLANS AND ACTIVITIES

The following narrative was submitted by this school.

The School Development Plan for Continuous Improvement of Bristow Middle School included the following goal: To create an Environment and Community that Fosters Intellectually, Physically, and Emotionally Healthy Learning. The Advisory program was a tool used to build strong relationships and teach students the skills they needed to address their social and emotional needs. Bristow implemented the Second Step Program to help create a safe school climate for all students, both emotionally and physically. A focus at Bristow was to develop positive home-school partnerships where every student and family felt a sense of belonging. The Safe School Climate Committee met monthly as they focused on creating a positive and safe school climate. A Positive Behavior Interventions and Supports System (PBIS) was implemented to enable students to follow the expectations of Work Hard, Be Safe, Be Fair. This proactive approach contributed to establishing a positive learning environment and a safe school climate in which everyone was able to achieve academically and socially. Consistent school wide expectations were taught, modeled, and reinforced in all settings. Bristow continued to focus on creating and improving programs that provided added support to students in the areas of literacy and numeracy. District department supervisors assisted teachers in their departments in the infusion of literacy into their disciplines. Formal goals and objectives of classroom teachers were centered on student achievement. A building schedule was developed to allow for added instructional time for students who were struggling in the areas of literacy and numeracy. Instruction was scheduled for five days each week, and was provided by a reading specialist and a certified math teacher. The focus of these reading and math classes was to provide direct instruction on identified areas of weakness in collaboration with the students' regular math and language arts teachers. A tutoring program utilized parents and community members as tutors. The tutors worked individually with students who were identified through the guidance department. The Guidance Department provided support for students in the areas of organization and homework completion. Support was also provided to students after school in the Homework Center. Finally, teachers met daily as a team to discuss student progress and data. Individual Performance Plans were created for students who were struggling academically or behaviorally and needed additional classroom interventions. A Clinical Team met weekly, and as needed, to address students who were in greater need of assistance in academic, social, or emotional areas.

SUPPLEMENTAL SCHOOL INFORMATION

We continued to expand our initial efforts to create a school that meets the need of the whole child:

Advisory program continued where students were assigned an advocate and placed in small groups. Students participated in team building activities and community service projects such as creating Thanksgiving food baskets that were donated to the West Hartford Social Services Department. These baskets were distributed to local families in need.

Our theater program continued with the performance of Annie.

Students participated in the publication of the Pencil Point magazine and the Bristow yearbook.

Students designed and operated a school store.

The Student Council sponsored the following community outreach projects: Mitten & Hat drive, Valentine's for the neighborhood convalescent home, and Quarters for Crohn's fundraiser.

We continued our extensive musical performance groups. These groups continued to excel at juried festivals.
